Plan ahead! Your family will be thankful!

The biggest mistake people make is not having a plan at all. There are many different options and planning tools available. Finding the right fit for YOU is the key! None of us want to think about the chance of becoming incapacitated or disabled, but unfortunately many of us will. We don't want to think about our passing but unfortunately we ALL will. What happens if we are not prepared? Sadly, many people are unprepared and can be a costly mistake. Much of what we have worked so hard to preserve could be spent on unintended beneficiaries—the government, court fees, the nursing home, etc.—costing our loved ones thousands of dollars.

Disability planning allows you to decide who you want to make financial or medical decisions on your behalf if alive, but unable. If you are unable to execute disability documents, a Guardianship and/or Conservatorship may need to be initiated where the judge appoints someone to make your decisions. Simple ways to plan for disability is to execute a

Power of Attorney and a Health Care Directive – allowing you, not the judge, to decide who makes the decisions on your behalf.

Probate is the legal process that transfers title of your property after you have passed. A Will is essentially instructions to the judge stating your family members, beneficiaries, Personal Representatives, property and preferred distributions. A few ways to avoid probate: on all accounts have a joint owner, a beneficiary designation or transfer the asset to a Trust. Upon death the joint owner retains full rights, the named beneficiary inherits the asset or the Trustee distributes the asset per the terms of the Trust.
